Directive No. 1/2023 of the Bursar of FAMU

Operating Rules of Galerie AMU (GAMU)

I. Principal provision

These Operating Rules are issued with a view to ensuring the efficient and secure operation of Galerie AMU, Malostranské náměstí 12/259, 118 00 Praha 1 ("GAMU").

GAMU is accessible to the general public during its opening hours as specified on the website.

Admission at other times is possible subject to an arrangement with the Head of GAMU to be made via gamu@fam.cz or using the telephone number provided on the GAMU website.

III. Instructions for visitors

1) Visitors with special needs can visit GAMU if the condition of the exhibition venue so permits.

2) General instructions for visitors:

- a) Unless determined otherwise or permitted by GAMU personnel, it is forbidden to tamper with GAMU exhibits and/or equipment in any manner.
- b) It is forbidden to bring to GAMU premises any illegal or hazardous substances or objects that could endanger or compromise the operation of GAMU.
- c) It is forbidden to damage GAMU's internal equipment in any manner.
- d) Visitors should not enter GAMU if they are aware that they are or could be infected by an infectious disease.
- e) Visitors shall refrain from any acts that could endanger the security of persons or objects on the premises of GAMU.

- f) Visitors are obligated to observe safety and operating instructions of AMU employees.
- 3) Any visitor who culpably causes any damage to GAMU shall be obligated to compensate for it to the full extent under applicable legislation and other legal regulations of general application.
- 4) Exhibition organisers reserve the right to regulate the number of visitors to GAMU with a view to observing the defined safety and operating rules.
- 5) Visitors agree that, by attending an event organised at GAMU, they consent to the fact that an audio-visual recording of the event will be made, in which they may be captured, and that it may be used for AMU's presentation purposes.
- 6) Visitors can voice their opinions and suggestions via e-mail to gamu@famu.cz.
- 8) If a visitor fails to obey an instruction or prohibition issued with a view to the protection and security of the exhibits, facility and visitors, such a visitor may be ejected from the premises immediately. In addition, such a visitor faces the risk of penalty under applicable legislation and other legal regulations of general application.

IV. Final provisions

These Operating Rules were discussed by the GAMU Exhibition Board on 14 October 2022 and they take effect on 2 January 2023.

Any provision of the Operating Rules may be amended subject to the approval of the Dean and/or the FAMU Bursar.
